

MANUFACTURER CERTIFICATION STATEMENT FOR QUALIFIED ENERGY PROPERTY

The Further Consolidated Appropriations Act of 2020, signed into law on December 20, 2019 by President Trump, renews an amendment to § 25C of the Internal Revenue Code. The amendment allows tax credits for energy efficiency improvements to an existing home including *Gas Hot Water Boilers* that are placed into operation in 2018 through 2020.
